Re: Waste Management (Registration of Brokers and Dealers) Regulations 2008

Dear Sir/Madam,

Further to our receipt of your completed Brokers and Dealers registration form, please find enclosed a copy of your certificate of registration. The registration number quoted on this certificate is to be used when filling out all TFS forms (i.e. Notification Documents, Movement Documents and Annex VII forms) and should be quoted on any future correspondence with the National TFS Office.

In addition to the requirements for Amber List waste, the National Transfrontier Shipment Office (NTFSO) of Dublin City Council has introduced a pre-notification and charging system for the export of Green List waste. **From the 12th July 2008, any person who arranges the shipment of Green Listed waste shall be required to provide certain information by email on a monthly basis to the NTFSO regarding shipments proposed for the next business month.**


